AAUW Fund

The Lompoc-Vandenberg branch was well-represented at the recent Interbranch Councilsponsored Fellows Luncheon. Held at the Santa Maria Country Club on Saturday, February 25, the theme was "Leadership for Women, by Women." The featured keynote speaker was Aileen Rizo who holds a Master's in Educational Technology and a second Master's in Mathematics Education.

Aileen related her experiences with Fresno's County Office of Education that led to her lawsuit claiming gender and wage discrimination. The AAUW Fund's Legal Advocacy monies have helped

Aileen in her legal battle which has culminated in a hearing at San Francisco's Federal District court. Bay Area AAUW members were present to offer in both sign-holding and hand-holding.

Previously interviewed by Maria Shriver of NBC, garnering national attention, Aileen and her personal testimony supported the Fair Pay Act passed by the California Legislature. The Act has become the strongest equal pay bill in the nation.

Aileen is waiting for the panel of judges' decision, and when asked by an attendee if she would take her case to the U.S. Supreme Court if that became necessary to win, she made eye contact with her husband and daughters and gulped, "Yes."

All the current and retired teachers at the luncheon know how crucial salary steps are, with short-term and long-term consequences. Others remember being asked about past salary amounts, sometimes on job applications, sometimes in a personal interview. We were immediately sympathetic to Aileen's issues. She and her family received a standing ovation.

I was fortunate enough to meet and chat with Sharon Westafer, the California Director for AAUW Fund, who regularly sends me e-mail reports on donations. She makes herself readily available to handle any questions or issues that may arise at the branch and state levels regarding AAUW Fund.

In addition, Sharon provided brief remarks to the larger general group of Central and South Coast branch members in attendance, as did Donna Mertens, CA President, and Susan Pease, Tech Trek Camp Director at UCSB.

Like many women, AAUW members give for social impact and I am extremely proud of our branch as a small part of Aileen's struggle for pay fairness.

Public Policy

Public Policy: If you go on the AAUW website to their Public Policy section, you will find copies of letters being sent from the national office to elected officials. Here is a section of a letter sent in January to the leadership in Congress regarding AAUW support for Planned Parenthood. AAUW advocacy for our priority issues merits our individual support as members. I am proud to see AAUW listed along with 130 faith-based and women/family advocacy groups.

"The more than 130 undersigned organizations stand united in support of Planned Parenthood and the millions of women, men, and young people who rely on Planned Parenthood health centers every day. We oppose any attempt to block patients from accessing the high-quality,

affordable health care that Planned Parenthood provides.

"In 2014, Planned Parenthood health centers served 2.5 million patients, providing over 4 million sexually transmitted infection (STI) tests and treatment, 360,000 breast exams, 270,000 Pap tests, and birth control for 2 million people. One in five women has visited a Planned Parenthood health center for care in her lifetime, and many rely on Planned Parenthood as their primary health care provider. These health centers play a critical role in providing access to primary and preventive care to many people for whom it would be otherwise inaccessible. Seventy-five percent of Planned Parenthood's patients have incomes at or below 150 percent of the federal poverty level, and more than half of Planned Parenthood's 650 health centers are located in rural or medically underserved areas.

"The current defunding effort is the latest phase in a long-discredited smear campaign against Planned Parenthood premised entirely upon highly edited and misleading videos which alleged wrongdoing by Planned Parenthood and other abortion providers. Since the release of those deceptive videos, these allegations have been investigated extensively and rejected by multiple congressional committees and 13 different state investigations, which have found no evidence of wrongdoing. In fact, a Texas grand jury tasked with investigating Planned Parenthood instead indicted the makers of these falsified videos.

"There is no doubt that if this attack succeeds, many patients will lose access to a range of basic preventive health care services, including birth control, STI and cancer screenings, and other lifesaving care—and low-income families will be hit hardest. If Congress were to block all Medicaid patients from seeking care at Planned Parenthood health centers, the Congressional Budget Office (CBO) estimates that 390,000 women would lose access and up to 650,000 women could face reduced access to preventive care within a year. Many of the organizations signing this letter work on behalf of those who rely on Planned Parenthood's compassionate, high-quality care and know how important it is that it continues to be available to those who need it."
