One of the big topics in the news lately is sexual harassment. Harvey Weinstein, Bill O'Reilly, Roger Ailes, Bill Cosby... and the list goes on as more and more come forward with allegations of sexual harassment. You can find an excellent article at <u>www.aauw.org</u> entitled "Know Your Rights: Workplace Sexual Harassment". Sexual harassment is a form of sex discrimination that violates <u>Title VII of the Civil</u> <u>Rights Act of 1964</u>. Very generally, "sexual harassment" describes unwelcome sexual advances, requests for sexual favors, or other verbal or physical conduct of a sexual nature. Did you know there are generally two types of sexual harassment claims? 1. Quid pro quo: an employment decision — like a promotion, an assignment, or even keeping your job — is based on your submission to the sexual harassment. 2. Hostile work environment: the sexual harassment makes your workplace environment intimidating, hostile, or offensive. Read more about this topic on the website.

We had an excellent speaker in October, Dr. Sarah Thébaud, who spoke on "Gender Bias at Work: What is the problem and how can we fix it?" There are often subconscious biases that affect employment and promotions—people are really not aware of the biases that they have that cloud their decision making. She recommended a book by Joan Williams entitled "What Works for Women at Work." So whether it is blatant sex discrimination or subconscious biases, there is still the gender pay gap and a lack of women in leadership roles in both government and business. # **Public Policy**

I recently added the Lompoc Vandenberg branch website to my bookmarks and found that from there, I can access the Two Minute Activist site to weigh in on current legislation. Here are two important educational issues currently being addressed:

#### Public Funds for Public Schools: Oppose Private School Vouchers!

"Public funds belong in public schools. When those funds are re-directed to private and religious schools through school voucher programs, we put the education and civil rights of women and girls at risk. Private and religious schools are not held to the same civil rights and accountability standards as public schools, and for this reason, AAUW has long opposed the use of public funds for voucher programs.

Urge your members of Congress to stand up for public education by opposing private school voucher programs!

Although promoted as "school choice," vouchers do not provide true choices for students and parents. Not all public school students can access voucher schools, as private schools can reject any applicant they choose. Most concerning, private schools often do not have to adhere to federal civil rights laws, specifically Title IX, allowing for the discrimination of students on the basis of sex, disability, or English language ability.

It is imperative that we use taxpayer dollars for educational programs that are held to high standards and measures of accountability. Voucher programs provide little accountability to taxpayers because many private schools do not adhere to the same curriculum and reporting requirements of public schools. Research has also shown that voucher programs do not improve academic opportunity and student performance; students enrolled in voucher programs usually perform at the same level or below that of students in public schools.

Take action now. Tell Congress we shouldn't give our tax dollars to unaccountable private schools.

Instead of funneling federal taxpayer dollars to private schools, Congress should invest these funds in public schools that are accessible to all students, no matter their gender, disability, economic status, or educational achievement."

#### Tell Congress: Stand Up for Dreamers! Pass the Dream Act Without Amendment

"For the past five years, the Deferred Action for Childhood Arrivals (DACA) program has provided nearly 800,000 recipients the ability to attend school, go to work, and contribute to our economy without fear of deportation. But with a simple swipe of the pen, President Trump has moved toward ending the DACA program, taking with it the opportunity for thousands of immigrants to achieve the American Dream.

DACA recipients – also known as Dreamers – are an integral part of our communities. Ninety-seven percent are either in school or employed. One-quarter are enrolled in institutions of higher education while another third are in high school and considering their options for postsecondary education and

career training. AAUW understands the impact that education has on the lives of students and on the nation's overall prosperity and strength. The DACA program has opened the doors to higher education for thousands of Dreamers, while developing a skilled workforce prepared to compete in the global economy. Our commitment to increasing opportunities in education for all women and girls stands firm.

#### Tell Congress: Stand Up for Dreamers! Pass the Dream Act Without Amendment (Continued)

The President's decision to end DACA is both morally and fiscally irresponsible and Congress must take action. Tell Congress we must protect Dreamers and pass the Dream Act today!

The Dream Act is a bipartisan, bicameral bill that would offer many, including DACA recipients, protection from deportation while allowing them to continue to access education or work and contribute to our society. Our higher education system and our economy are stronger because of contributions of DACA recipients." *Marell Brooks, Public Policy Chair*
